WORDS OF HOPE



The month of February begins with a Groundhog Day ceremony held at Punxsutawney in western Pennsylvania, is based on a semi-mythical groundhog named Punxsutawney Phil. This event centers on the Pennsylvania Dutch superstition that if a groundhog emerges from its burrow on this day and sees its shadow, it will retreat to its den and winter will go on for six more weeks; if it does not see its shadow, spring will arrive early.

Radon in your home



January was National Radon Action Month. Learn more about this colorless and odorless radioactive gas.

Research shows that the air within homes and buildings can be more polluted than outdoor air. The average person spends approximately 90% of their time indoors. A potential indoor air pollutant of concern is radon.

What is radon?

Radon is a colorless and odorless radioactive gas. It is formed during the breakdown of uranium, which is found in nearly all soils and rocks. Radon ranks among the most serious environmental health problems facing our nation today.

How does radon get indoors?

High levels of radon in the soil are primarily responsible for indoor radon problems. Radon seeps into homes through gaps or cracks in the foundation floor or walls, sump pits, drains or other openings. Once confined in an enclosed space such as a home, it can accumulate to unhealthy levels.

What are the health risks?

The United States Environmental Protection Agency estimates that residential radon exposure is responsible for 7,000 to 30,000 lung cancer deaths per year. The Surgeon General has warned that radon is the second leading cause of lung cancer in the United States. Only smoking causes more lung cancer deaths. If you smoke and your home has an elevated radon level, your risk of lung cancer is especially high.

How do you find out if radon is a problem in your home?

Data indicates that in Macomb County approximately 5 - 10% of the homes will have elevated radon levels. Since radon is odorless and invisible, the only way to know if your home has a radon problem is to test for it. Free, easy-to-use radon test kits are available to Macomb County residents through the Macomb County Health Department. These easy-to-use kits allow you to check your home for radon. Test kits can be reserved by calling the Macomb County Health Department at 586-469-5236. After you have reserved your kit, it will be available for pickup at the Health Department's Central Health Center in Mount Clemens located at 43525 Elizabeth Road during normal business hours of 8:30 a.m. - 5 p.m.

What can you do if your home has a radon problem?

A variety of methods are used to reduce radon levels in homes. The cost of making repairs depends on the design of your home and the extent of the radon problem. The average house costs about \$1,200 to fix, although repairs can range from about \$500 to \$2500. Contact the Macomb County Health Department to obtain a list of contractors that have completed federal and/or state radon remediation training programs.

The CMWC is looking for people who might be interested in some pantry-related activities at times other than pantry day.

- 1. We need people to help pack boxes in-between pantry days. There is some lifting needed, 35lbs boxes. If you cannot lift, you could help fill boxes with dry goods which doesn't require lifting. The time commitment for this task would be 1 1.5 hours per packing party once a month.
- 2. We need folks to help us with bottle returns once a month on Monday mornings at 9:30 am. The time commitment for this task would be 1-1 1/2 hours. There is some lifting needed to take the bags of bottles out of the trailer, and put them in a shopping cart. Can't lift? No problem. Someone will help you. The \$\$ we receive from the returnables goes to support our food pantry.
- 3. We need some men/young adults to help unload food from a vehicle and bring it in to the church on the Friday before pantry and on the 1st and 3rd Wednesdays of the month. The time commitment for this task varies depending upon traffic and waiting time at Gleaners or Macomb Food Bank.
- 4. The CMWC is also looking for people to join our committee. You know about our work with the pantry. We support other outreach projects as well. The time commitment for membership on the Committee is a 2-hour meeting once a month on the Tuesday before pantry. Additional time will be needed if you wish to participate in any of our outreach projects.

Hope United Church of Christ Synopsis of Board Meeting January 21, 2025

The meeting was called to order at 7:03 p.m. by President Steve Nielson. Pastor Meg led us in prayer.

Those in attendance: Pastor Meg, Steve Nielson, Nancy Burnham, Terri Hillman, Kirk Schoenherr, Linda Parsons, Linda Rehm and Nany Fay. Absent: Jerry Rogers and Lori Sarnowski. Guest: Barry Burnham at the time of the first item of New Business.

Congregational Comments - Steve - None

Additions to the Agenda - Steve - Delete from New Business - Super Bowl February 8th. Add to New Business - Barry Burnham to join our meeting and discuss Insurance Audit. Also add LaToya Young re a letter for file request - Pastor Meg.

Approval of Agenda – Motion to approve the agenda as amended with the one deletion and two additions was made by Nancy Burnham with a second by Linda Rehm. Motion carried.

President's Remarks – Steve – Welcome all back to the New Year. Hope you all enjoyed the holidays with family and friends. Received a thank you from Deborah for the gift card. All Committee reports are due January 26th and at the very latest by February 2nd for the Annual Report. Since the next meeting will be the last meeting with current Board, could it be at church on February 11th with a short meal at 6 pm and the meeting at 7 pm. No one objected.

Approval of the November Meeting Minutes – Motion was made by Nancy Burnham with a second by Kirk Schoenherr to approve the November meeting minutes. Motion Carried.

Treasurer's Reports for November and December 2024 – Motion was made by Linda Rehm with a second by Nancy Fay to approve the reports for both November and December. Motion Carried. Only the December 2024 report is shown below:

The following items summarize the financial results for the month of December:

- Statement of Operations Income (Page 3):

 Weekly Offerings for December 2024 were \$2,064 more than the amount budgeted but \$1,268 less than the amount received for December 2023. There were five December Sundays in both years. Year to date Weekly Offerings \$4,067 less than the amount budgeted but \$401 (\$7 per week) more than the same period in 2023. We also received Special Offerings of \$1,715 for Christmas, \$105 for Energy, \$5 for Church Growth, \$135 for Our Church's Wider Mission, \$155 for One Great Hour of Sharing, \$555 for Neighbors in Need, and \$815 for the Christmas Fund (VOC) in December.
 - The only Investment activity for the Operating Fund consisted of \$0.46 in interest to the Money Market Account.
 - Year to date Operating Income, comprised of Weekly Offerings plus other Income accounts, is \$1,484 less than the amount budgeted but \$1,045 more than 2023.













Statement of Operations – Expense (Pages 4-6):

- Total Operating Fund Expenses for December 2024 were \$26 more than the amount budgeted and \$2,082 more than the Expenses for December 2023. Year to date Expenses were \$7,869 less than budgeted with favorability primarily driven by the open Christian Education Director position and associated Christian Education costs, as well as lower heating cost. That favorability was partially offset by higher electricity and grounds upkeep costs, office supplies and administrative expenses, and cost associated with increased church life activities. Year to date 2024 Expenses were \$5,075 more than the same period of 2023 due, in large part, to a \$2,470 November charge for tree pruning.
- There was a gain (Income less Expense) of \$3,211 in December 2024 versus a gain of \$5,334 December 2023.

Dedicated Accounts (Page 7):

Dedicated Accounts had income of \$7,493 and expense of \$340 for the month, leaving a balance of \$102,235.

Building Fund (Page 9):

Hope for the Future offerings received in December 2024 were \$1,540 (adjusted for the December reclassification of a
June offering specifically allocated to parking lot repair) which was \$35 less than the amount budgeted and \$310 less th
the amount received for December 2023. Year to date Hope for the Future offerings were \$3,544 more than the amoun
budgeted and \$2,599 more than the amount received in 2023. We have received Memorials of \$4,295 year to date. Or
additional invoice for \$300 for the parking lot repair was received and paid in December, bringing the total paid in 2024
the repair to \$107.756.

Investments (Page 9):

 The securities account had a December loss of \$6,215 compared to a gain of \$10,916 for December 2023. Year to dat 2024, the securities account had a gain of \$45,926 versus a gain of \$42,317 for the 2023.

Insurance Audit Update – Barry Burnham, Insurance Advisor: Barry Burnham joined our zoom meeting at this time. An audit was done for paid employees and outside vendors that work for the church. The Treasurer supplied the information which is highly confidential and the audit was sent in by the deadline. Every vendor must supply a copy of their Certificate of Liability Insurance that includes a box checked if they have Worker's Compensation Insurance and the amount. Two out of our twelve to fifteen vendors did not show they had Worker's Compensation on their Certificates of Liability Insurance. One of them has since supplied additional information to our insurance company. Since the insurance is based on the prior year, we will probably have to pay more for our insurance due to this one vendor not having Worker's Compensation Insurance in the prior year. We currently have a contract with this particular vendor thru the end of March 2025. We have had this particular vendor for the last three years and feel that our Insurance Company (Hartford Insurance) just decided to point out that he was without the required insurance due to all the recent claims that Insurance Companies are currently facing all over the country. We are very pleased with this vendor's work and would hate to lose this vendor.

After some discussion as to whether we should keep this vendor till the contract ends and if we are willing to pay more for services to help cover the cost of the vendor obtaining Worker's Compensation Insurance, it was decided that a motion be made to have Steve contact the vendor and discuss Worker's Compensation options by Nancy Burnham and supported by Kirk Schoenherr. Motion Carried. We will need to obtain a new vendor if this vendor will not obtain a Worker's Compensation Insurance Policy.

We thanked Barry for his time in presenting this audit report and he left the zoom meeting.

Nominating Committee Update – Nancy Burnham: The Committee consisted of Ida Eckert, Rick Cole and Nancy Burnham. They spoke with a lot of people and have five that are willing to run and we have five vacancies needing to be filled. The five nominees are Jim Wilson, Cynthia Greening, Carissa Spear, Brad Lusk and Rick Cole. At the Congregational Meeting, if there are no other candidates from the floor, we will proceed to elect these five nominees. We will have ballots ready if there are nominees from the floor.

Set Annual Meeting Date – Steve Nielson: Sunday, February 23, 2025 at 11:15 in person only in the Fellowship Hall. Would like to have child care available so all parents of young children could attend. Will ask the Confirmands to help out.

Audit Committee – Steve Nielson: Norm Nenninger, Bob DeGryse and Tom Reeser will be the Committee and they will be joined by Terri Hillman. A tentative date has been set for Friday, January 31, 2025 at 10 am at church.

Review Baby Shower for Jesus – Nancy Burnham and Terri Hillman: A great event with lots of people attending. Two children were baptized that Sunday so this could have contributed to the number of people attending. A wonderful luncheon of salads, sandwiches and cake was served. There was lots of generosity from Hope UCC. It was a heart warming experience delivery the gifts to Macomb Foster Closet. Thank you to all who worked on this event. Pastor Meg requested that Nancy Burnham and Terri Hillman make some notes so we could easily duplicate this great event at another time.

Review of Advent Season – Pastor Meg: Great concert by the Motor City Chorale. It was great having them at the very beginning of the Advent Season. We need to arrange to have them back in the spring and next advent season. We really need to have a designated team to organize the pageant and perhaps start planning it in the summer so there will be no need for a lot of rehearsals right at Christmas when everyone is so busy with other activities. The Board had some discussion of the various activities that took place during Advent. The Blue Christmas service was on-line only and had a better turnout than when we had it in-person. Pastor Meg suggested we explore other organizations or school connections as recipients of the toys. Terri Hillman suggested possibly contacting the Macomb Foster Closet. Pastor Meg also suggested we need more volunteers for special meals including a clean-up crew. She also suggested the possibility of hiring musicians for special services like Easter and Christmas Eve. Our choir and bells do a great job but some members are not always available particularly for the Christmas Eve service due to family commitments. Deborah could help us find paid musicians. Members of our Congregation would be given the opportunity to donate towards the cost.













Upcoming Lenten Season - Pastor Meg: Lent does not begin this year until March 5th (Ash Wednesday). It is much later this year. It was February 14th in 2024. The Board will have more discussion of Ash Wednesday and Holy Week at our next Board Meeting in February since there is still plenty of time.

Pastor Meg would like to have two studies for the Lenten Season. The first seminar will be for "Planning your own Memorial Service". Each person would write their own plan for their memorial service and then keep a copy for their own records and have a copy on file at the church. Pastor Meg would also talk about planned giving during this seminar. The second study would be reading and reviewing the book "You Can't Ask That!, 50 Taboo Questions about the Bible, Jesus, and Christianity".

Confirmation of Tessa and Casey is being planned for March 23. On Palm Sunday we will have a petting zoo and either a breakfast or super coffee hour and a visit by the Easter Bunny. Traditional Holy Week will follow.

Update Church Rental - Pastor Meg: A few months ago we reached out to Matt Skubik to possibly help us find future renters. We will only be listing with him and we can say "no" to any renter for any reason. Pastor Meg will follow up with Matt.

LaToya - Pastor Meg: Recently she and her wife became members of Hope Church. LaToya is a member in discernment "someone who is seeking ordination in the UCC". She was a member of a different UCC church and is now a member of Hope Church. She would like to have something in her file stating she is a current member of a UCC church. She will be preaching at Hope on February 2, 2025. Pastor Meg will be present on that Sunday. A motion was made to draft a letter for her to have in her file by Nancy Fay with a second by Nancy Burnham. Motion Carried.

Pastor's Report - Pastor Meg:

Worship: We had 13 families participate in the pageant with a total of 22 youth. We had seven new members join on December 22nd.

Church Business: Gail worked her first Advent/Christmas season at Hope. She did an excellent job keeping track of all the necessary communication and worship service. We are preparing for the Annual Meeting and the Repots due to the UCC.

Spiritual Council: The group met in December to prepare for Advent and Christmas. We will meet next week. We will have another new member class on February 9th. We need to promote our Hope Ambassador opportunities.

Pastor Relations should meet in the spring.

Christian Education: I am still preparing lesson plans and gathering supplies. Jordan and Kristin are faithful teachers. My goal is to have the new Christian Education committee meet in February. Confirmation is scheduled for Tessa and Casey on March 23rd.

Community Outreach: Both AA and PFLAG sent us Christmas greetings. AA made an additional donation to the church for allowing them use the building on Thanksgiving Day.

Consent Agenda Items - Steve received only one report from the Property Committee for the month of December. Motion was made by Terri Hillman with a second by Nancy Burnham to accept this report as submitted. Motion carried.


